Para No.17.4.

Furthermore the worthy GM Baluchistan / Sindh-II at Sukkur has given directions during the meeting that select the suitable attached/ mortgaged property purchase/ acquire the property in Public Auction proceeding conducted by the Honorable Banking Court Sukkur.

It is noted that during the course of hearing proceeding regarding public auction in above attached property the Honorable Judge Banking Court No-II Sukkur was given verbal directions that at the time of Public Auction proceeding the concern branch Manager should be provide the details of penaflix / drum beating , picture and video clip to Nazir Banking Court No-II Sukkur, if any Branch Manager not follow the Court directions the action will per taken as per Law. that where branch paste /announcement of drum beating
